UPDATE: PRO WINE JUDGING

Professional Wine Coordinator Quince reported that there are 913 wines entered into the competition. She will be confirming one last judge. She referenced the schedule and safety protocols that had been shared with the board. Judging will take place Tuesday, September 15 and Wednesday, September 16. Director Lowe explained that the medals and best of class wines will be announced on September 20. The Best of Class wines and gold medal winning brands will be published in the Press Democrat. All awards will except sweepstakes will be posted at harvestfair.org. The sweepstakes wines will be announced on September 27 through a video being produced by Sonoma County Winegrowers. Director Tesconi explained that Sonoma County Winegrowers will also be producing and releasing a teaser video on September 20.
